GENERAL INFORMATION

The **Weyburn WEYBEX AWARDS** are open to businesses, organizations and individuals, in the City of Weyburn and the immediate area. Nominees may submit their own nomination or a third party may submit the nomination. All nominations must include signed consent of the nominee. Nomination forms are enclosed in this package or are available at the Weyburn Chamber of Commerce office.

Membership in the Weyburn Chamber of Commerce is not mandatory to participate in this awards program.

The nominator may submit a nomination in any or all categories from the following six WEYBEX Categories:

Business of the Year Award will be selected from **all** nominations excluding Business Hall of Fame.

A nominee may be nominated in more than one category, but may only win in **ONE** category. Also, a nominee may not win in the same category for 2 consecutive years, but this does not preclude winning in different categories in consecutive years. Sponsors of particular categories as well as members of the WEYBEX committee may be nominated in any category, however it will be their decision on whether or not they wish to let their name stand.

The Judging Committee at the request of the nominee will bring forward past nominations (from the previous Weybex Awards only) in specific categories for consideration in the current year subject to the nominees approval and meeting the category criteria.

The Judging Committee reserves the right to re-assign a nomination into a more appropriate category in order to avoid possible disqualification.

STEP 1 Complete the nomination in typewritten form corresponding to the category or categories you have chosen to enter. **There are separate nomination forms for each category.** Have the nominee review the completed nomination form, and agree to its content and submission by signing the consent portion. If there is insufficient space on the nomination form for all your comments, please provide attachments. We ask that you limit your comments to not more than one page ensuring that they remain factual, focused and specific to the category of the nomination. Enclose any additional materials you feel are pertinent (e.g. documents, photos, news clips) and please identify if you wish these to be returned.

STEP 3 All nominations will be reviewed by the WEYBEX Selection Committee comprised of local individuals who shall remain anonymous. In occasions of conflict of interest, judges will refrain from voting.

Any information you provide will remain confidential.

Winners will be selected from a maximum of 3 finalists in each category, and up to 3 winners will be selected from a maximum of 6 finalists in the Business Hall of Fame.
